### 369.2 BALLYMONEY MOTORCYCLE SHOW

The Ballymoney Motorcycle Show is to be held in the Joey Dunlop Leisure Centre on 5<sup>th</sup> & 6<sup>th</sup> March 2010.

The organisers have requested financial support with the cost of using the Leisure Centre. The Council in the past has financially supported the show. The organisers have also extended an invitation to the Mayor to open the show and to all other members of Council who wish to attend.

It was proposed by Alderman Campbell, seconded by Alderman Connolly and  
**AGREED:**

***to recommend that Council grant £800 to the Ballymoney Motorcycle Show towards the cost of using the Joey Dunlop Leisure Centre for a two-day event to held on 5<sup>th</sup> & 6<sup>th</sup> March 2010.***

### **369.3 RIADA PRE 1950 CAR CLUB**

The Riada Pre 1950 Car Club has written to the Council advising that they are having a display of Vintage Cars at the Joey Dunlop Leisure Centre on 3<sup>rd</sup> April 2010 and request financial support with the cost of using the Leisure Centre.

### **369.6 LOUGH NEAGH AND LOWER BANN ADVISORY COMMITTEES**

The Director informed the meeting that correspondence had been received from the DoE Minister, dated 12<sup>th</sup> February following an Assembly debate on 9<sup>th</sup> inst., advising that both the Department and DCAL would reinstate their funding for a further year, if each constituent Council confirmed its funding for 2010-2011. He also advised that the Minister was requesting each Council to confirm its funding for 2010-2011 by 8<sup>th</sup> March and also forward the name of the Council's nominee to serve on the Lower Bann Advisory Committee. The Director then reminded members that Council had included a contribution of £2,500 in its budget for the in-coming financial year as its contribution to the Lower Bann Advisory Committee [LBAC]. He also stated that the question of which member would represent Council on that body ought to be dealt with at the March Council meeting in order to give members time to consider this.

It was proposed by Alderman Campbell, seconded by Councillor McCamphill and **AGREED:**

***to recommend that Council make a contribution of £2,500 to the Lower Bann Advisory Committee for 2010-11, as had been provided for in the budget.***

### **369.7 DERVOCK RE-IMAGING COMMUNITIES PROJECT (LAC 345.6)**

The Director reviewed the project and then circulated plans of the proposed 'finalised' piece, which had both funder and community approval, to be placed on Council land at Dervock Riverside Park. He advised that were Council also to be content with the proposal then a planning application would be made, with a view to having the piece in place as soon as possible. The Director reminded members that in order for the project to be realised Council would, as it had previously agreed, have to undertake certain 'work in kind' such as providing the base, granite setts and floodlighting. He also reminded members that there would be an on-going commitment as regards the cost of electricity into the future.

It was proposed by Alderman Campbell, seconded by Councillor McCamphill and **AGREED:**

***to recommend that Council confirm its previous commitments to the Dervock Re-Imaging Communities Project and apply for the necessary planning permission.***

### **369.8 COLLAPSED PATH AT RIVERSIDE PARK**

The Director advised that following the Council's budgetary provision for a scheme to re-instate the collapsed path, etc., at Riverside Park, Ballymoney, that he would recommend that Council commence the project and in this regard advertise in order to create a contractor select list.

It was proposed by Alderman Connolly, seconded by Alderman Campbell and **AGREED:**

***to recommend that Council commence the project and advertise for a contractor select list in respect of the scheme required to reinstate the collapsed path at Riverside Park, Ballymoney.***
